
19 **ORDER**

20 Before the Court is the Receiver's Notice of Motion and Motion for Order
21 Approving and Awarding Receivers Interim Fees and Expenses; Memorandum of
22 Points and Authorities; and Supporting Declaration of Richard Weissman ("Fourth
23 Fee Motion"), which seeks an Oder approving and awarding fees incurred by the
24 Receiver and his Staff during the period of March 1, 2015 through February 29,
25 2016 ("Interim Fee Term"). Appearances were made by the Receiver, Richard
26 Weissman ("Receiver"), pro se, by Maricela Segura, Esq., counsel for Plaintiff,
27 Federal Trade Commission, and counsel and interested persons as set forth in the
28 Court's hearing minutes.

1 The Court having considered the papers in support of, and in opposition to,
2 the Fee Motion, and good cause appearing therefor, the Court orders:

- 3 1. The Receiver's Fourth Fee Motion is hereby granted;
4 2. The interim fees incurred by the Receiver and his Staff during the
5 Interim Fee Term, as discounted by the Receiver, are approved and awarded in the
6 sum of \$79,392.25.
7 3. The Receiver's reimbursable expenses incurred during the Interim Fee
8 Term, in the sum of \$1,325.00 are approved and awarded.
9 4. The Receiver is authorized to pay his interim fees and expenses,
10 totaling \$80,717.25 from the Receivership accounts.
