**(“BAR DATE NOTICE”)**

**TO ALL INVESTORS AND INTERESTED PARTIES:**

**PLEASE TAKE NOTICE** that the Order Approving Distribution Plan (“the Plan”) entered on March 21, 2011, by the U.S. District Court, For the Central District of California, (“the Court”) directed the Receiver in this action, Richard Weissman, to determine the lawful claims of investors in *TRI ENERGY, INC.* (“*TRI ENERGY*”), and *MARINA INVESTORS GROUP, INC.* (“*MIG*”), arising out of the alleged conduct of, among others, ROBERT P. JENNINGS, ARTHUR SIMBURG, and HENRY JONES (collectively, “Tri Energy”).

**PLEASE TAKE FURTHER NOTICE** regarding filing proofs of claim:

**LAST DAY TO FILE PROOF OF CLAIM**

Any person or entity that asserts a claim or interest against Tri Energy for loans to or investments in Tri Energy ***must mail their*** proof of claim form to the Receiver, **postmarked on or before MARCH 31, 2012. This date is called the “Bar Date.”** That date is the last day by which a claim may be postmarked to be deemed “timely filed.” **Claims postmarked after the Bar Date may be denied by the Court. Denial of a claim will result in no distribution to a claimant of any portion of the funds controlled by the Court.**

All original Proofs of Claim must be **postmarked on or before the Bar Date** and mailed to the Receiver, at: 12121 Wilshire Boulevard, Suite 600, Los Angeles, California 90025.

YOU ARE REQUIRED TO SEND TO THE RECEIVER A FULLY COMPLETED AND SIGNED PROOF OF CLAIM IF YOU SEEK RECOVERY OF MONEY FROM THE FUNDS CONTROLLED BY THE COURT IN THIS CASE.

### **CONSENT TO JURISDICTION OF THE COURT**

By filing a proof of claim with the Receiver, you agree that the Court shall have jurisdiction over all claims identified in your Proof of Claim ("Claims") and over all aspects of your Claims, including but not limited to: (a) the allowed amount; (b) priority in distribution; (c) scheduling and allocation of the funds available to satisfy your Claims (if any are available); and (d) objections or disputes as to the allowed amount. You must file with the Court any and all objections and disputes you may have regarding your Claims, and serve a copy on the Receiver, pursuant to federal motion practice for a hearing and a final ruling thereon. The matter will be heard by the Court sitting without a jury.

**PLEASE NOTE:** A PROOF OF CLAIM MUST BE TIMELY POSTMARKED AND ACTUALLY RECEIVED BY THE RECEIVER OR YOU MAY BE COMPLETELY BARRED AND PRECLUDED BY THE COURT FROM PARTICIPATING IN ANY DISTRIBUTION OF THE ASSETS HELD BY THE COURT.
